 and described premises, with the appurtenances; that the same are free, clear, discharged and unincumbered of
 and from all former grants, titles, charges, judgments, taxes, assessments, and incumbrances of what nature and
 kind soever

and that he will warrant and forever defend the title to the same unto said parties of the second
 part, their heirs and assigns, against said party of the first part, his heirs, and all and every person
 whomsoever lawfully claiming or to claim the same.
