

This Indenture, Made this 31st day of March A. D. 1908, between J. M. Hall and Jennie S. Hall, his wife of Tulsa County, in the State of Oklahoma, of the first part, and J. M. Gillette of the second part,

WITNESSETH, The said parties of the first part, in consideration of the sum of Eleven thousand (\$11,000.00) and no DOLLARS, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell and Convey unto the said part 1 of the second part, his heirs and assigns, all of the following described real estate, situated in the County of Tulsa and State of Oklahoma, to-wit:

And said parties of the first part for their heirs, executors or administrators, do hereby covenant, promise and agree to and with said part 1 of the second part, that at the delivery of these presents they are lawfully seized in their own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincumbered of and from all former grants, titles, charges, judgments, taxes, assessments, and incumbrances of what nature and kind soever except an oil and gas lease to Grant C. Stebbins, his heirs or assigns and that they will warrant and forever defend the title to the same unto said part 1 of the second part, his heirs and assigns, against said parties of the first part, their heirs, and all and every person whomsoever lawfully claiming or to claim the same.
