

This Indenture, Made this 4th day of April A. D. 1928, between

Frank Chulby of Tulsa County, in the State of Oklahoma, of the first part, and John O. Mink of Tulsa County, Oklahoma, of the second part,

WITNESSETH, The said part 4 of the first part, in consideration of the sum of one dollar and other valuable consideration and        DOLLARS, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell and Convey unto the said part 4 of the second part, his heirs and assigns, all of the following described real estate, situated in the County of Tulsa and State of Oklahoma, to-wit:

Lot or parcel of ground out of the southwesterly parts of Block 5 and 6 in Block 133 in the town of Tulsa, Oklahoma, being 70 ft x 150 ft more particularly described as follows:

Beginning at the southwest corner of Block numbered 133; thence in an easterly direction, along the south line of lot numbered 5, 70 ft; thence, at a right angle, in a northerly direction 150 feet; thence in a westerly direction and at a right angle, a distance of 70 feet, to the west line of lot numbered 6; thence in a southerly direction, along east line of said lots 5 and 6 a distance of 150 feet to the place of beginning on said lots and blocks as shown on the recorded plat thereof also all lots eleven (11) and twelve (12) in Block numbered seven (7) - in the town of West Tulsa, Oklahoma, - according to the recorded plat thereof.

TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, forever.

And said Frank Chulby for his heirs, executors or administrators, do hereby covenant, promise and agree to and with said part 4 of the second part, that at the delivery of these presents he is lawfully seized in his own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincumbered of and from all former grants, titles, charges, judgments, taxes, assessments, and incumbrances of what nature and kind soever

and that he will warrant and forever defend the title to the same unto said part 4 of the second part, his heirs and assigns, against said part 4 of the first part, his heirs, and all and every person whomsoever lawfully claiming or to claim the same.
