One & 100 (\$100.00) and DOLLARS,the receipt whereof is hereby acknowledged, do hereby presents Grant, Bargain, Sell and Convey unto the said part of the second part, to his heirs and assigns, all of the following described real estate, situated in the County of Tulsa and State of Oklahoma, to-wit:All of the north half (1/2) and the southwest quarter 1/4 of the northeast quarter of sec. 15, in Township 17 N. and range 13 East, amounting to 120 acres, more or less, as the case may be according to the U. S. Gov't survey thereof.
