without demand an the same and any other moneys disbursed by the holder of said indebtedness to protect the lien hereof with interest from the date of payment at the rate of 10 markers of per annum, shall be so much additional indebtedness secured hereby.

In the event of a breach of any of the aforesaid covenants or agreements or 66 the passage by the State of a law imposing payment of the whole or any parxixx portion of any taxes or assesments aforesaid upon the grantee of his successor or the holder of said in debtednes, or upon the rendering by any court of comptent jurisdiction of a decision that the undertaking by the grantors as herein provided, to pay such taxes or assessments is legally inoperative, the whole of the in ebtedness secured hereby, including principal and all accrued interest, whthout deduction, shal' at the option of the legal holder of the said indebtedness, without notice become immediately due and collectal ble, notwithstanding anything contained in this Trust Deed or any law hereafter enacted and with interest therefrom f/om the date of such maturity at the rate of IO % per annum shall be recoverable by foreclosure hereof i manner as if all of said indebtedness had then matured by express terms . It is agreed by the grantors that in case the right of foreclosure so arises hereunder, either uppn maturity of said principal note or by breach of any of the covenants or the happening of any of the contingencies aforesaid the granteem or his successor, may upon request of the legal holder of said pirncipalxxo note, bring such legal proceedings for the collection of the moneys hereby secured as may be necessarry; that all expenses and disbursements paid or incurred in that behalf in connection with s ch legal proceedings, including a reasonable attorney's fee outlays for documentary evidence, stnographer's charges, costs of procuring or completing an abstract showing the whole title to said premises and embracing the judgment ordering sale thereof, shall be paid by the grantors and the like expenses and disbursemns to ocassioned shall also be paid by the grantor's. All such expenses and disbursements shall be an additional lien upon said premises and shall he taxed as costs and included in any judgment that may be rendered in such proceedings; which proceedings shall not be dismisse nor a release hereof given until all such expenses and disbursements and the cotts of suit have been paid . The grantors waive all right to the possession of and the income from said premises pending such foreclosure proceedings and agree that a Receiver Ashall by appointed to take possession or charge of said premises and collect such income, cand the same, less Receivership expenses, apply upn the indebtedness hereby secured .

In case of the death, disability, resignation or temporary or permanent absence from the City of Chicago of the grantee Harry Lee Taft, Oren k Taft of the City of Chicago, Illinois, is hereby appointed as his successor in turst, and in case like disqualification of both Harry Lee Taft and Oren E Taft to act as such Trustee as aforesaid, then the legal holder or holders of the principal note secured hereby shall have the right to apoint a trustee by endorsement of such appointment on this Trust Deed; and either of said substitute Tr stees shall have the same powers and duties inall respects whatseever a s if first named as Trustee herein. And the action of said Oren E Taft or said endorsement and the action of said second substitute Trustee shall be conclusive evidence, respectively of his right and duty to act as such substitute Trustee.

Provided Alawys that when all of the aforesaid covenants and agreements are performed the grantee or his successor shall release said premises from the lien hereof.
