It further appearing to the Court that no special mode of sale was required by said will of the said decedent, and that said sale was legally made and fairly conducted; that the sum paid was more than 90% of the appraised value of said lot, and that no greater sum than above specified could be obtained; and,

It further appearing to the Court that the said executrix filed her return of said proceedings of said sale on the said 27th, day of November, 1908, as stated herein; amd,

IT IS FURTHER ORDERED that the executrist make, execute and deliver to the said purchaser a good and sufficient fleed of conveyance to the property sold, conveying all of the right, title and interest of the said decedent in and to said property at the time of his death.
