ORDER OF COURT.

ORDER.

Now, on this the 14 day of December, 1908, upon the petition of Charles Page, asking for an order of Court approving a certain deed by Mary Emarthla, nee Bird, otherwise known as Mary Emarthala, neefuss, executed, conveying to the said Charles Page, her interest in andto the landers described below, the said petitioner appearing in person and by her attorneys, Abbott & Brown and the Court after hearing the evidence and the testimony and listening to the argument of counsel and being fully advised in the premises, f inds:

That the allegations in said petition contained are true, that the said Harjo, Salmer and Fus Thlocco, deceased, were full blood Creek Indians; that there was allotted to the said Harjo the following described land, situate in Tulsa County, Oklahoma.

The Northeast Quarter of Section 10, Township 19 North, Range 11 East; that the said Harjo died seized of the said lands on or about the 24th, day of Mat, 1900, in and while a resident of Tulsa County, Oklahama; that there have been no children born to him since the 4th, day of March 1906; that said Mary Emarthla, nee Bird, is a sister and an heir at law of said Harjo, deceased. That the said Salmer had allotted to her the following described land, situate in what is now Tulsa, County, Oklahoma:

The South-half of the Northwest Quarter and the North Half of the Southwest Quarter of Section 11, Township 19 North, Range 11 East. and the said Salmer died seized of the said lands on or about the 19th, day of June 1900, in and while a resident of Tulsa County, Oklahoma, and there have been no children born to her since March 4th, 1906, and that the said Mary Emarthla nee Bird, is the daughter and heir at law of the said Salmer.

The Court further finds that the said Harjo and the said Salmer, deceased, died intestate, The Court further finds that the said Mary Emarthla, nee Bird, on the 4th, day of December 1908, made, executed and delivered unto Charles Page, the petitioner, her deed of conveyance thereby conveying to the said Charles Page all her right, title and interest in and to the lands above described, and other lands, for a good and valuable consideration therein expressed, which consideration the Court finds is adequate; which said deed was filed in the office of the Register of Deeds of Tulsa County, on the 8th, day of December, 1908, in Book 48, at page 296, thereof.
