One rooom (directly across the hall from room now occupied as Manager's office) in the Bynum Building on Lot 7, Block 105, with the appurtenances and privileges therewato belonging for the term as follows: To commence on the first day of June, 1907 and terminate on the first day of December, 1914 at the yearly rent or sum of Sixty (\$60.00) Dollars, payable \$5. per mo. in adv., with the exclusive right of establishing and maintaining a telegraph, telephone and electric signal office in said building during the said term, the said party of the first part to keep said premises in good and tenantable condition during the occupancy of said leasee.
