

The second party agrees that it will commence drilling operations on the allotment of some one of the above named parties, in Township Twenty, Range Twelve East within fifteen days from date hereof. That if second party at any time secures a hundred barrel oil well upon the allotment of any of the above parties, then in that case, second party agrees to pay said minors and Ida L. Haworth a bonus of Ten (\$10.00) Dollars per acre and to Lucile S. Brannon, nee Haworth a bonus of Fifteen (\$15.00) Dollars per acre.

The party of the second part shall have the right to use oil, gas and water produced on said land, free of royalty, for drilling and operating thereon, except water from wells of first party. When requested by the first party, the second party shall bury pipe lines, except steam lines below plough depth. Second party agrees to drill all necessary off-sets.

The party of the second part shall have the right to at any time remove all machinery and fixtures placed on said premises, including the right to draw and remove casing from all dry or exhausted wells.

The party of the second part, its successors and assigns, shall have the right at any time on the payment of One (1.00) Dollar and all payable obligations then due to the party of the first part, his heirs or assigns, to surrender this lease for cancellation, after which all payments and liabilities hereafter to accrue under and by virtue of its terms shall cease and terminate.

All covenants and agreements herein set forth between the parties heretofore shall extend to their heirs, successors, executors, administrators and assigns.
