## RELEASE OF MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS: THAT THE FARM AND HOME SAVINGS AND LOAN ASSOCIATION OF MISSOURI a corporation organized and doing business under the laws of Missouri, at the City of Nevada, in said State, for and in consideration of One Dollar, and for other valuable considerations the receipt of which is hereby acknowledged, do hereby remise, release, convey, satisfy, discharge and quit claim unto Henry Kinsel and his wife Nannie J. Kinsel, of Tulsa, Oklahoma, all the right, title and interest, claim or demand whatsoever, it may have acquired in, through or by a certain mortgage bearing date of February 20th, 1908, and recorded in the Office of the Register of Deeds at Tulsa, Oklahoma, in Book 30, at Page 487, to the premises herein described as follows:

The Easterly Twenty five ( 25 ) feet by One Hundred (100) feet fronting Twenty five (25) feet on East First Street and running back Northerly and adjoining the alley with a uniform width of Twenty five (25) feet a distance of One Hundred (100) feet, also: The Westerly twenty five (25) feet more particularly described as follows: That part of Lot Numbered Four (4), beginning at the Southwesterly corner of Block Numbered Seventy six (76) running thence Northeasterly along North line of First Street Twenty Five (25) feet; Thence Northwesterly parallel with West line of said lot one hundred (100) feet; Thence Southwesterly parallel with First Street twenty five (25) feet; Thence Southwesterly on West line of said Lot Four (4) one hundred (100) feet to the place of beginning, all in Lot Number Four (4) in Block Numbered seventy six (76). Also Lot number Six (6) in Block Numbered Seventy Six (76) in the town (now City) of Tulsa, Indian Territory (now State of Oklahoma) according to the official plat and survey thereof and allowing the variation of the townsite from the true meridian, and all improvements thereon. Together with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining.
