RELEASE OF MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS:

THAT THE FARM AND HOME SAVINGS AND LOAN ASSOCIATION OF MISSOURI, a corporation organized and doing business under the laws of the state of Missouri, at the City of Nevada, in said State, for and in consideration of One Dollar, and for other valuable considerations, the receipt of which is hereby acknowledged, do hereby remise, release, convey, satisfy, discharge and quit claim unto Henry Kinsel, single and unmarried of Tulsa State of Oklahoma, all the right title, interest, claim or demand whatsoever, it may have acquired in, through or by a certain mortgage bearing date of April 20th, 1906, and recorded in the Office of the Register of Deeds at Tulsa, State of Oklahoma, in Book "D" at Page 30, to the premises herein described, as follows:
