DEED OF EXECUTRIX.

THIS INDENTURE, Made this 11 day of December, 1908, by and between Emily M. Campbell, of Tulsa, County of Tulsa, State of Oklahoma, executrix of the last will and testament of Wilbur Emory Campbell, deceased, of the first part, and E. G. Cunningham, of Tulsa, County of Tulsa, State of Oklahoma, of the second part:

WITNESSETH: That , Whereas, under the terms of the said last will and testament of the said Wilbur Emory Campbell, deceased, said will having been admitted to probate in the County Court of the County of Tulsa, Syste of Oklahoma on the 10th, day of December, 1907, power was given to the said executrix, Emily M. Campbell, to dispose of, in such a manner as seemed to her fitting, and all real estate decedent died seized of, and to sell and convey the same by good and sufficient warranty deeds; and,
