OF MAJORITY. O R D E R.

This casue coming on to be heard on the 31" day of December, 1908, before the Honorable L. M. Poe, Judge of the District Court in and for Tulsa County, Oklahoma, upon the application and petiton of Laura B. Lloyd by her next friend James P. Lloyd to have the rights of majority cofferred upon Laura P. Lloyd, a minor to the extent of empowering and authorizing said minor to execute an oil and gas lease upon the W/2 of NE/4 of NE/4 and SE/4 of NE/4 of NE. 4 of Section 19, Township 20 North, Range 13 East for the term of ten years and as long thereafetr as oil or gas of either of them is produced therefrom. And it appearing to the Court that due and legal notice of said application and petition has been given by publication for two consecutive wears prior to presenting and filing said petition, in the Tulsa Chief a newspaper of general circulation, printed in Tulsa County, State of Oklahoma: and the Court having heard testimony in open court, finds that the said petitioner Laura B. Lloyd is of the age of between sixteen and seventeen years; that she is of sound mind, fully able and competent to transact her own affairs, in so far as it pertains to all things concerning the leasing of said lands and contracting and handling all her interest in connection therewith: that the interest of the said petitioner, Laura B. Lloyd will be materially promoted by conferring the rights of majority as asked for in the prayer of the petition,

That said Laura B. Lloyd and James P. Lloyd are residents of Tulsa County, Oklahoma, and have been such residents for more than one year next preceeding the filing of the petition in the case. That said minor Laura B. Lloyd is the owner of the above described land which lies in the oil and gas belt and is unable to lease the same for oil and gas purposes to the best advantage of said minor, on account of the short period a lease would have to run during her minortity; that it would be to the manifest interest of said minor to have the rights of majority given her as prayed for in her petition on file herein.

It is therefore by the Court, considered, ordered, adjudged and decreed in pursuance of authority conferred by the laws of the State of Oklahoma, particularly Section 3833 of the Statutes of 1903, that the rights of majority concerning contracts of lease of land hereinafetr described be and the same hereby are conferred upon the said Laura B. Lloyd, minor, and that said Laura B. Lloyd minor, is hereby authorized and empowered to lease for oil and gas purposes the W/2 of NE/4 of NE/4 and SE/4 of NE/4 of NE/4 of Section 19, Township 20 North, Range 13 East, containing thirty acres, more or less, for the term of ten years and as long there as oil and gas or either of them is produced therefrom, and to do any and all things by contract or otherwise that is necessary to be done or performed in the execution, delivery and transferring ttile by lease of said land, to sign any and all papers necessary in handling and disposing of the oil and the paofits therefrom and to have power to contract ge nerally and in particular with reference to any lease said minor may execute upon said land, and that all such actions, contracts and things dome as herein set out shall be with the same effect as if done and performed by a person over the age of majority.
