that the said Andwe Fox also left second cousins, the grand children of a sister of Andwe Fox's mother, the mother of said grand-children being named Petse, but having died prior to the death of the said Andwe Fox; that the said second cousins aforesaid are as follows: Millie Bighead, Ekalarney Cahwee, Peter Cahwee and Willie Campbell, now deceased, he having left a daughetr named Han nah Campbell.

The Court finds that all of said Indians are full blood, and so enrolled.

The court further finds that there was allotted to the said Andwe Fox as her share of the lands of the Creek Nation, the following described real estate in the Creek Nation, Indian Territory, now Tulsa County, State of Oklahoma, to wit!

The Southeast Quarter (.4) of Section Fourteen (14), Township Sixteen (16) North of Range Thirteen (13) East of the Indian Meridian, and in Tulsa County, Oklahoma, considing of 160 acres, more or less.

The Court further finds that the said Minnah Davis has sold and conveyed her interest in said land to G. W. Barnes this day, and has executed to him a warranty deed for same, the consideration being Six Hundred and Fifty Dollars (\$650.00) that said sum is a fair and reasonable price for said interest of said Minnah Davis, and that it is to her best interest that said sale be made.

It is therfore ordered and adjudged that the said deed and conveyance of the said Minnah Davis to the said G. W. Barnes for the above described lands is in all things approved and confirmed.

ORDER APPROVING LEASE.

This matter came on to be heard on this 2" day of January, 1909, upon the petition of John Harry, guardian of Willie Harry, a minor, asking for an order of the Court approving and on-firming his action in making and executing for and on behalf of said minor, Willie Harry, an oil and gas mining lease run ning to John A. Steele, which said lease has been presented to this court for approval.

The petitioner appearing in persona nd by his attorneys Abbott & Brown, and the Court a fter hearing the testimony of the petitioner and the testimony of disinterested witnesses as to the value of the lands described in the lease for oil and gas mining purposes and after hearing the argument of counsel and being fully advised in the premises, finds:
