THAT, WHEREAS, on the 14th, day of June, 1906, Monday Durant, guardian of Edith Durant, a minor, entered into an oil and gas mining lease with the Galbreath Oil and Gas Company, covering the East Half of the Northwest Quarter of Section Fifteen (15) Township Seventeen (17) North, Range Twelve (12) East in the Creek Nation of the Indian Territory, which said lease was approved by the United States Court for the Western District of the Indian Territory, and,

WHEREAS, Robert W. Morrison, Charles W.S. Cobb, Frank M. Breene and John E. McKinney have appealed from the order of the United States Court for the Western District of the Indian Territory, at Sapulpa approving said lease to the said Galbreath Oil and Gas Company to the United States Court of Appeals for the Indian Territory, where the action of the United States Court for the Western District of the Indian Territory at Sapulpa so approving said lease to the Galbreath Oil and Gas Company was affirmed, and the said Robert W. Morrison, Charles W. S. Cobb, Frank M. Breene, William J. Breene and John E. McKinney thereupon appealed said matter to the United States Court of Appeals for the Eighth Circuit, where same is now pending; and

WHEREAS, the said Robert W. Morrison, Dharles W. S. Cobb, Frank M. Breene, William J. Breene and John E. McKinney have heretofore filed protests with the Secretary of the Interior against the approval of the lease executed by said Monday Durant to the said Galbreath Oil and Gas Company as guardian of his ward Edith Durant, and also as guardian of his ward Edna Durant;

And, WHEREAS, at a hearing of said protest by the Secretary of the Interior, a compromise settlement of the whole controversy was suggested by the Honorable Sectetary of the Interior whereby the said calbreath Oil and Gas Company should assign to the said Robert W. Morrison, Charles W. S. Cobb, Frank M. Breene, William J. Breene and John E. McKinney all of its right/ title and interest in and to the Southeast Quarter of the Northwest Quarter of Section Fifteen (15), Township Seventeen (17) North, Range Twelve (12) East, under and by virtue of its lease covering the East Half of the North West Quarter of Section Fifteen, Township Seventeen North Range Twelve East, hereinbefore mentioned, and the said Robert W. Morrison, Charles W. S. Cobb, Frank M. Breene/William J. Breene/And John E. McKinney to pay therefor the sum of Eight Thousand Five Hundred and Fifty Dollars, and to withdraw their protest against the approval of the lease above mentioned; and

NOW, THEREFORE, in consideration of the forregoing, and of the sum of Eight Thousand, Five Hundred and Fifty (\$8,550.00) Dollars cash in hand paid the Galbreath Oil and Gas Company by the said Robert W. Morrisen, Charles W. S. Gobb, Frank M. Breene, William J. Breene and John E. McKinney, receipt whereof is hereby acknowledged, and divers other good and valuable considerations, the said Galbreath Oil and Gas Company has granted, bargained and sold and hereby grants, bargains, sells, conveys and setd over to the said Robert W. Morrison, Charles W. S. Cohb, Brank M. Breene, William J. Breene and John E. McKinney all right, title and interest, both legal and equtable of what nature whatsoever, in and to the Southeast Quarter of the North West Quarter of Section Fifteen (15)/ Rownship Seventeen (17) North, Range Twelve (12) East in the Creek Nation of the Indian Territory, under and by virtue of a certain oil and gas lease made and executed by Monday Durant, Guardian of Edith Durant, a minor, to it on the 14th, day of June, 1906, and running until the 6th, day of September, 1917.
