paying quantities, yielding to the lessors the one eighth part of all the oil produced and saved from the premises, delivered free of expense into tanks or pipe lines to the lessors credit .

Should a well be found producing gas only, then the lessors shall be paid for each such gas well at the rate of One Hundred & Fifty Dollars for each year so long as the gas is sold therefrom, payable quartely while so marketed . \*

Lessee agrees to complete a wwell on said premises within six (6) months from the date hereof, or pay the lessors thereaft er the sum of Fifty sents per acre per annum En advance until a paying well is competed or this leases surrendered and the drilling of a paying will shall be full consideration to lessors for grantymade to lessee with exclusive right to drill one or more additional wells on the premises during the term of this lease.

Lessors are to fullquse and enjoy said premises for the purpose of tillage except such parts as may be used by lessee for the purpose aforesaid . Lessee is not to put down any well on the lands hereby leased, within ten rods of the buildings now on the said premises without the consent of the lessros in writing. Lesses may ,/if any well or wells on said premises produce sufficient gas, have gas for domestic purposes for one family, the lessors paying for connections at such points as may be from time to time designated by lessee).

The above rental shall be paid to lessors in person or by check depaited to their credit in the First National Bak of Tulsa. And it is further agreed that lessee shall have the right to surrender this lease upon payment of One (\$1.00) Dollar and all amounts due hereunder and thereafter shall be released and discharged from all payments, obligations, covenants and conditions herein containsed, whereupon this lease shall be null and void, and Wall conditions, terms and limitations, between the parties heretoshall extend to their heirs, successors, personal representatives and assigns .

Lessors agree that the recordation of a deed of surender in the proper County and a deposit of all amounts then due, hereunder to lessor's credit in First National Bank of Tulsa shall be and be accepted as full and legal surrender of lessec's
