KNOW ALL MEN BY THESE PRESENTS:

That the New State Investment Company, a corporation, has caused the West Half (1/2) of the East Half (1/2) of the Northwest Quarter (1/4) and the West eighty-six (86) feet of the East Half (1/2) of the East Half (1/2) of the ^{Northwest} Northeast Quarter (1/4) of Section Seven (7) Township Nineteen (19) North, Range Thirteen (13) East, to be surveyed and platted into streets, alleys, lots and blocks, as is shown by the plat of J.C. Cobb, filed in the office of the Clerk of the U.S. Court for the 28th recording District of the Indian Territory, on the 4th day of October A.D. 1906, and to be known as the Forest Park Addition to the City of Tulsa, Indian Territory .

That all streets and alleys (except two hundred seventy (270) feet on the South end of Park Avenue, and three hundred (300) feet of said Avenue lying between Magee Street and East Eleventh Street, and all that part of Forest Avenue between Roosevelt and South Street. ^{of the free consent and desire of the owner hereby} are dedicated for the use of the Public .

That all lots and blocks are reserved for sale and use .
