This case coming on in its order to be heard, and the Court being fully advised in the premises, and it appearing to the Court that said Aurella Franklin and said Irene Franklin, are citizens of Muskogee County, State of Oklahoma, and as such citizens have had ~~lands~~ allotted to them, and now own in fee simple the following described land, respectively to-wit:

AURELLA FRANKLIN

The southwest Quarter (SW 1/4) of Section Thirty Six (36) Township Nineteen (19) North, Range Eleven (11) East containing One Hundred and Sixty (160) acres, situated In Tulsa County, State of Oklahoma .

IRENE FRANKLIN

The Northeast Quarter (NE 1/4) of Section Thirty Five (35) Township Nineteen (19) North, Range Eleven (11) East containing One Hundred and Sixty (160) acres, situated in Tulsa County, State of Oklahoma .

And it further appearing that said Aurella Franklin and Irene Franklin are the only persons interested in said land . And it further appearing that it is for the best interests of said minors to have said above described lands developed for oil and gas, in order that funds may be obtained for the proper education, maintenance and support of said minors; and it further appearing that the estates of said minors are not financially able to develop said lands for oil and gas purposes; and it further appearing that under and order of this Court heretofore made and issued said Thomas Franklin has executed to J.A. Hull and A.B. Reese of Tulsa Oklahoma, an oil and gas mining lease on the above described land of said minors, respectively; and it further appearing that said J.A. Hull and said A.B. Reese have paid therefor as a bonus the sum of One Hundred and Sixty (\$160.00) Dollars for ~~such~~ tract respectively; and it further appearing that said sum is a good and sufficient bonus for said oil and gas mining leases; and is as much as could be obtained therefor; and it further appearing that said Thomas Franklin and said Aurella Franklin and said Irene Franklin are residents of Muskogee County, State of Oklahoma .

NOW, THEREFORE/, It is ordered, adjudged and decreed that the said oil and gas mining leases executed/as aforesaid by said Thomas Franklin, as guardian of Aurella Franklin and Irene Franklin, to said J.A. Hull and said A.B. Reese, and covering the above described land of Aurella Franklin and Irene Franklin, respectively, and the same is hereby in all respects ratified, confirmed and approved .
