For and in consideration of Eight Dollars to him in hand paid receipt of which is hereby acknowledged Thos Franklin Bdn of his minor child Aurella Franklin of Boynton Okla do hereby grant to the Oklahoma Natural Gas Company/ a corporation, its successors and assigns, the right of way to lay, maintain, operate, re-lay and remove pipe lines for the transportation of gas, and erect, maintain, operate and remove telegraph and telephone lines if same shall be found necessary on, over and through certain lands situate in Tulsa a County, Oklahoma, described as follows :-

S 2 of S W 4 of Section 36 Township 19 N Range II east line to be laid on portion of land set apart for use as a public highway. with ingress and egress to and from the same. The said grantor his heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said Oklahoma Natural Gas Company/ and it is hereby further agreed that the above payment is in full for all damages for the constructing, maintaining, operating, relaying and removing the said pipe lines. And that the said Oklahoma Natural Gas Company, its successors or assigns may at any time lay an additional line of pipe alongside of the first line herein provided, upon the payment of a like consideration, and subject to the same conditions.
