

, boiler-houses, tool houses, pipe -lines, pumping and drilling outfit, shall remain the property of the said party of the second part, and may be removed at any time before the expiration of sixty(60) days after the termination of the lease .

That they will not permit any nuisance to be maintained on the premises under their control, nor allow any intoxicating liquors to be sold or given away ^{for} ~~for~~ any such purposes on such premises; that they will not use such premises for any other purpose than those authorized in this lease, and that before abandoning any well, they will securely plug the same according to law . It is further understood and agreed that said lessees may at any time terminate ^{at} this lease by surrendering same to lessor and paying to said lessor the sum of Five Dollars .
