This agreement made and enter ed into this 26th day of February I906 by and between W.F.Applegeet and Cora F Applegeet of Bixby Indian Territory, party of the First part and Frank Edwards party of the second part Witnesseth:-

The said party of the first part hereby rents, leases, and remises to the said party of the secondpart for a period of five years from the first day of January I906 the S W Quarter of the N W quarter and the West Half of the S E quarter of the N W quarter of section I8 Township I7 N Range IS E, Creek Nation Indian Territory. For the use and as a rental for said land the said party of the second part agrees to pay One Hundred Dollars (\$ 100.00 of which amount Fifty Dollars (\$50.00) is to be paid at the delivery of this contract, the recipt of which is hereby acknowledged, and the remaining Fifty Dollars (\$50.00) to be paid the first day of January I907. In addition to the above amount the said party of the second part agrees to make the following improvements:

To build a house I2 X 20 feet with walls 9 feet high, said house to be built of native lumber except floors which shall be of pine, and roof of either shingles of clapboards, and build a corn crib IO X 20 of native slats with shed IO feet wide full
