WITNESSETH: That the said first party has this day rented or leased to the said second party for agricultural and grazing purposes, for a term of five years, beginning on the above named date and ending on the 23rd day of June 1913, the following described real estate situated in the County of Tulsa, State of Oklahoma to-wit :-

N/2 of the NW/4 of the SE/4 and the SW/4 of the NW/4 of the SE/4 of section Four (4) Township Twenty One (21) North and Range Thirteen (13) East.

The said second party agrees to pay to the said first party as rent for ~~xxx~~ said land the sum of Fifty \$50.00 Dollars, being in full payment in advance for the five-year lease above named, receipt of which is hereby acknowledged by the said first party.

The said first party agrees to give immediate possession of said land and states further that there are no other leases on the above described land. No contract other or different from this shall be claimed by either of said parties unless the same is in writing and signed by both of them.

THIS INDENTURE of Lease, Made and entered into in quadruplicate on this 17 day of June A.D. 1908 by and between John Bullett, Guardian of Floyd C Bullett, a minor of Claremore Oklahoma party of the first part, and Thomas E Bruzmet of Denton Texas party of the second part.

WITNESSETH: That the party of the first part for and in consideration of the royalties, covenants stipulations and conditions hereinafter contained and hereby agreed to be paid, observed and performed by the party of the second part, his heirs, executors, administrators, successors or assigns, do hereby demise, grant and let unto the party of the second part, his heirs, executors, administrators, successors
