In the County Court within and for the County of Wagoner, and State of Oklahoma, sitting in matters of Probate .

In re guardianship of the estate :

Decree of Court.

Now on this 7th day of April 1908 the same being one of the regular days of the March 1908 term of said Court, the above entitled cause coming on to be heard, upon the petition of Alex Hawkins, the ward herein, heretofore filed in this Court, in which he sets up that he was of age of Twenty-One years on the 10th day of August 1905, and in which he therefore prays that the said Thomas Blair, guardian herein be discharged because of said ward's majority, and that a final report of the acts and doings of the said Guardian, together with an accounting of Guardianship funds, received by him, and of the disbursements in said guardianship account, and the court having heretofore issued a citation to said Guardian to appear in Court, in response to said citation, in person and represented by Counsel, and this cause now coming on for further hearing, upon the said petition, and the denial thereto, entered by the guardian in open court, and the Court having heard the testimony of witnesses produced before the Court by the petitioner herein, in support of the allegations of said petition and having heard the argument of counsel herein, and now being well and sufficiently advised in the premises doth find.

That the said Alex Hawkins has reached his majority, and is over the age of twenty-one years; that the said guardian should be discharged, because of the majority of the said ward.

It is therefore considered, adjudged, decreed and ordered that the said Thomas Blair shall forthwith file in this Court his final report of his acts and doing as such guardian, and an account of amounts received by him, and disbursements made therein, together with proper vouchers covering such expenditures, and that upon such a report being filed and approved by this Court, that the said Thomas Blair be, and he is hereby ordered discharged from said guardianship.

To all of which order and appeal the said guardian prayed an appeal, which is this day allowed.
