That for and in consideration of the sum of One Hundred and Sixty Dollars (\$ 160.00) cash in hand paid , the receipt of which is hereby acknowledged the said L.R.Lewis and his wife Kate Lewis do by these presents hereby grant, assign, transfer and setover unto the said E.R.Minshall and R.L Davidson that certain oil and gas Mining lease on the east Half of the northwest quarter and the south half of the south west quarter of Section 21, Township 19 north, Range 11 east, executed and delivered to the said L.R.Lewis on the 30th day of June 1908 by W.G. Cooper as guardian for Wheeler Cooper, approved by the County Judge for Tulsa County Okla., on the ____ day of July 1908 and recorded in the office of Register of Deeds for Tulsa County Oklahoma in Book 37 page 152, and all their rights, title, interest and privileges in and to said land under the terms and conditions of the said lease .

This lease, made and entered into this 7th day of July 1908 by and between Gabriel Mc Intosh and Roxie Mc Intosh husband and wife, parties of the first part, and J.W.S. Bower party of the second part :

Witnesseth , That the parties of the first part, for and in consideration of the sum of One Hundred Dollars , cash in hand paid, the receipt whereof, is acknowledged at the execution of this instrument, has this day leased and by these presents does lease unto the party of the second part, for a period of three years, from the first day of January 1911 until the first day of January 1914, for agricultural purposes the following premises, to-wit:
