## -----Assignment of Lease :-----

THIS INDENTURE, made and entered into this 24th day of July 1908 by and between R.L.Davidson of Tulsa Oklahoma, first party and Philip Kates of Tulsa Oklahoma, second party, witnesseth :-

That for and in consideration of the sum of eighty dollars (\$80.00) cash in hand paid, the receipt of which is hereby acknowledged, the said R.L. Davidson does by these presents hereby grant, assign, transfer and set over unto the said Phillip Kates one half of his interest in that certain oil and gas mining lease on the east half of the northwest quarter and the south half of the southwest quarter of section 21, township 19 North range 11 east of the Indian Meridian, executed and delivered to L.R. Lewis on the 30th day of June 1908, by G.W. Cooper as guardian for Wheeler Cooper and approved by the County Judge for Tulsa County Oklahoma, on the 7th day of July 1908, and recorded in the office of the register of deeds for Tulsa County Oklahoma in Book 37 page 152 and assigned by the said Lewis and his wife to E.R.Minshall and R.L.Davidson on the 17th day of July 1908, which assignment was recorded in the office of the register of deeds for Tulsa County Oklahoma in Book \_\_\_\_\_ page \_\_\_\_\_ and a one half interest in and to all of the Grantor's rights, title interest and privileges in and to said land under the terms and conditions of said lease.

To have and to hold the said interest in the aforesaid premises during the life and under the terms of said lease and for the purposes therein set out, unto the said Phillip Kates his heirs and assigns.

## -----: OIL AND GAS LEASE :-----

AGREEMENT, Made and entered into this 13th day of July 1908 by and between Jim Ceasar guardian of Benjie Mc Intosh a minor, eleven years old of Muskogee Oklahoma party of the first part, and Guy Bowman of Muskogee Oklahoma party of the second part,

WITNESSETH : That the said party of the first part, for and in consideration of the sum of Forty (\$40.00) Dollars in hand well and truly paid by the said party of the second part, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the party of the second part, to be paid, kept and performed, has granted, demised / leased and let and by these presents does grant, demises lease and let unto the second party his heirs, successors or assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, constructing tanks, buildings and other structures thereon, to take care of said products, all that certain tract of land situate in the County
