Made and executed this 16th day of June 1908 by and between Dave Blackwood of Stilwell Indian Territory for and on behalf of himself party of the first part herein after called the lessor and the Southwestern Oil , Gas & Coal Co., party of the second part ( hereafter called the lessee ) of Oologah Indian Territory .

Now therefore, in Consideration of \$ 10.00 ( Ten Dollars ) the lessor rents to the lessee, his successors or assigns, the following described tracts of lands situated in the Cherokee Nation , Indian Territory to-wit:

The W 1/2 of the S E 1/4 and the S 1/2 of the S E 1/4 of the S W 1/4 of Section Seven (7) Township Twenty Two (22) Range (13 ) East containing One Hundred acres more or less .

To have and to hold said premises for agricultural purposes only for a term of five years from the date hereof for the consideration hereinbefore stated , the receipt of which is hereby acknowledged .
