Made and executed this 23 day of Sept 1904 by and between Geo W Mc Lemore, guardian of Rachel Christie, minor, for and on behalf of said Rachel Christie, minor party of the first part, hereafter called the lessor ) and L.J. Snarr Oplagah I.T. party of the second part (hereafter called the lessee )

Now therefore, In consideration of twenty dollars the lessor rents to the lessee , his successors or assigns the following described tracts of lands situated in the Cherokee Nation, Indian Territory , to-wit :

West 1/2 of the NE 1/4 of Section 8 Township 22 North Range 13 East containing 80 acres , to have and to hold said premises for agricultural purposes only for a term of five years from the date hereof for the consideration hereinbefore stated, the receipt of which is hereby acknowledged .

The lessor agrees that the possession to the above lands shall be given to the lessee from and after this date . The said L.J. Snarr agrees to build a good three wire fence around said premises, which improvements shall become and remain the property of the lessor .
