Made and executed this 20th day of September 1904 by and between Joe Black-  
bird of Uniontown Arkansas for and on behalf of himself, party of the first part (hereafter  
called the lessor) and L.J. Snarr of Oolagah I.T. party of the second part -(hereafter  
called the lessee)

Now therefore in consideration of \$ 20.00 and the improvements on the  
said land the lessor rents to the lessee, his successors or assigns, the following <sup>described</sup> tracts  
of lands situated in the Cherokee Nation, Indian Territory, to-wit:

The S E 1/4 of the N E 1/4 of Section 32, Township 22, North  
Range 13 East containing forty acres, more or less.

To have and to hold said premises for agricultural purposes only for a term  
of five years from the date hereof for the consideration hereinbefore stated, the receipt  
of which is hereby acknowledged. The lessor agrees that possession to the above lands  
shall be given to the lessee from and after this date. All to be fenced with a good  
three wire fence? No contract other or different from this shall ever be claimed by either  
of the parties hereto, unless the same is in writing and signed by each of them.
