Made and executed this 6th day of September 1904 by and between Ollie Bunch of Stilwell Indian Territory for and on behalf of herself party of the first part ~~there~~ after called the lessor- and Southwestern Oil, Gas ~~and~~ Coal Company of Oologah Indian Territory, party of the second part, ~~thereafter~~ called the lessee)

Now therefore , In consideration of \$ 1 .00 and the improvements on said land the lessor rents to the lessee , his successors or assigns the following described tracts of lands situated in the Cherokee Nation, Indian Territory to-wit :

The E 1/2 of the N E 1/4 of Section 8 Township 22 North Range 13 East containing eighty acres .

To have and to hold said premises for agricultural purposes only for a term of five y~~ears~~ from the date hereof for the consideration hereinbefore stated the receipt of which is hereby acknowledged .

The lessor agrees that possession to the above lands shall be given to the lessee from and after this date . All to be fenced with a good three wire fence .

All improvements placed on said land by the lessee or his assigns, may be removed by him or them at or before the expiration ~~different~~ from this shall ever be claimed by either of the parties hereto unless the same is in writing and signed by each of them .
