Now therefore, In consideration of \$ 1.00 and the improvements on said land the lessor rents to the lessee, his successors or assigns the following described tracts of lands situated in the Cherokee National Indian Territory, to-wit : The S E 1/4 of the S W 1/4 and the S 1/2 of the N E 1/4 of the S W 1/4 and the S W 1/4 of the S E 1/4 of the S E 1/4 and the W 1/2 of the N W 1/4 of the S E 1/4 and the W 1/2 of the S W 1/4 of the S E 1/4 of Section 3, and the N W 1/4 of the N W 1/4 of the S E 1/4 of Section 36, all in Townsh p 22 , North, Range 13 East .
