-----: AGRICULTURAL RENTAL CONTRACT :-----

This contract and agreement made and entered into this the 27th day of July 1908 by and between Susie Harjo and Janie Grayson heirs of Sunday Grayson, deceased, of Oklahoma, party of the first part, and Samuel Davis of Tulsa county, Oklahoma, party of the second part .

WITNESSETH : That for and in consideration of the sum of Two Hundred and Fifty Dollars (\$ 250.00) receipt whereof is hereby acknowledged and confessed, the party of the first part has this day and by these presents rented and leased unto the party of the second part, his executors, administrators and assigns, for agricultural purpose, for the term of five (5) years from the date hereof, the following described land, situated in Tulsa County, State of Oklahoma, to-wit : The N 1/2 of the N E 1/4 of Sec 15 and the N E 4 of the S E 4 of Sec 4, Twp 19 Rg 13 E (120 acres)

Parties of the first part represent that they have full authority to make said contract, that the above described land is not leased to any one else whatever, and that the stipulations of this lease shall faithfully be carried out by the said parties of the firstpart .

It is further agreed that the party of the second part has the exclusive privilege of cultivating said land and inclosing the same with a fence, sufficient to turn hogs, cattle, horses, or other stock , and of erecting improvements as may be found expedient, and shall have the right to clear away and dispose of the timber thereon, and that this lease is for agricultural purposes . All buildings, fences and other improvements erected upon said land shall remain the property of the said parties of the first part upon the expiration of this contract .
