

wells on the premises heretofore described within fifteen months from date of approval of this lease, that this lease stands forfeited at the option of the first party. Second party is to pay \$ 50.00 pper year for each gas well when gas is not being marketed .

Second party shall have the right to use sufficient gas, oil and water to drill all wells and to run all necessary machinery in operating the same . The terms and conditions of this grant shall extend to the heirs, successors and assigns of the parties hereto .

Now on this 18th day of July 1908 , this matter coming on to be heard upon the petition of Elmer L Collins guardian of Evelin Gazelle Collins a minor, to lease lands of minor for oil and gas mining purposes and it further appearing to the Court that a bonus of \$ 100.00 is offered by the Olive Oil Company, of Tulsa Oklahoma, and a royalty of One-eighth on all oil produced and saved from the premises owned by said minor and described as follows , to-wit :

It is therefore ordered by the Court that said guardian aforesaid make and execute an oil and gas lease to the Olive Oil Company and submit the same to the Court for confirmation or disapproval .
