

lot Six (6) in Block Two (2) of the Drew Addition to the City of Tulsa, Oklahoma, for the sum of \$550; and,

It further appearing to the Court that no special mode of sale was required by said will of the said decedent, and that said sale was legally made and fairly conducted; that the sum paid was more than 90% of the appraised value of the lot, and that no greater sum than above specified could be obtained; and,

It further appearing to the Court that the said executrix filed her return of the proceedings of said sale on the said 5th day of June 1908, as stated herein; and,

It further having been proved to the satisfaction of this Court that pursuant to the order of this Court made on the 5th day of June 1908, and the statutes of Oklahoma in such cases made and provided, there was published in the Tulsa Daily Democrat, newspaper published daily in the County of Tulsa, State of Oklahoma, for a period of ten days before the said 17th day of June, 1908, a notice that the executrix would, on the said 17th day of June 1908, apply for the confirmation of the said sale of the said property described, and

It further having been proved to the satisfaction of this Court by the affidavit of William Stryker, editor and publisher of the said Tulsa Daily Democrat, that the said notice was published the time required by the said order and Statute; and

It further appearing to the Court that the said sale has been made in conformity to the provisions of the Statutes in such cases made and provided:

NOW, on motion of Martin & Rice, attorneys for executrix, it is ordered and adjudged that the petition be and hereby is granted and the sale and the return of the proceedings thereof be and the same are hereby in all things approved and confirmed, and the Clerk of this Court is ordered and directed to make an entry on the journal of this Court that this Court is satisfied with the legality of this sale, and the said Clerk is ordered to record a certified copy of this order in the office of the register of Deeds in the County of Tulsa, Oklahoma.

It is further ordered that the executrix make, execute and deliver to the said purchaser good and sufficient deed of conveyance to the property so sold, conveying all of the right, title and interest of the said decedent in and to said property at the time of his death.
