The party of the seco d part its heirs, successors , or assigns shall have the right at any time on the payment of one dollar and all payable obligations then due to the parties of the first part, their hheirs or assigns, to surrender this lease for cancellation, after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine .

All covenants and agreements herein set forth between the parti es heretofore shall extend to their successors, heirs , executors, administrators and assigns .
