-----OIL AND GAS LEASE :-----

Agreement, Made and entered into the 30th day of June A D 1908 by and between D.N. Leerskov as guardian of Rachel N Leerskov a minor female born September 26th 1895 of Tahlequah Okla party of the first part and F.A. Gallispe of Tulsa Okla party of the second part,

WITNESSETH: That the said party of the first part for in consideration of the sum of One Dollar to him in hand well and truly paid by the said party of the second part, the receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of the said party of the second part, to be paid, kept and performed, hereby grants, demises, lease and let unto the said party of the second part, their heirs or assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, steam, water, gas and shackle lines to and from adjoining land, and of building tanks, stations and structures thereon to take care of said products, with the right of going in upon over and across said land for the purposes of operating the same; also with right to subdivide and release the same or any part thereof. All of the following described tracts of land situate in the County of Tulsa State of Oklahoma, Lot seven (7) and the Southwest quarter (SW $\frac{1}{4}$) of the Southeast quarter ($\frac{1}{4}$) of the northeast quarter ($\frac{1}{4}$) the North half (I/2) of the South east quarter ($\frac{1}{4}$) of the northeast quarter ($\frac{1}{4}$) and the southeast quarter ($\frac{1}{4}$) of the southeast ($\frac{1}{4}$) of the north east quarter ($\frac{1}{4}$) of section 2 T 20 R 12 E The w I/2 of SW $\frac{1}{4}$ of SE $\frac{1}{4}$ the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ and the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 35 of township 21 North range 12 East . of the Indian Meridian and containing one hundred ten and seventy eight one hundredths acres more or less .
