This indenture made and entered into in quadruplicate on this 27 th day of July AD I908 by and between Samuel Sawney of Stillwell Okla party of the first part and C.L.Brown of Tulsa Okla party of the second part, under and in accordance with the provisions of existing law and the rules and regulations presecribed by the Secretary of the Interior relative to grazing leases in the Cherokee Nationa, Oklahoma.

WITNESSETH: That said party of the first part for and in consideration of the covenants xxxx of the said party of the second part, hereinafter set forth does by these presents lease to said party of the second part, for grazing purposes only, the following des cribed tract of land lyijg and being within the limits of the Cherokee Nation and within the State of Oklahoma, to-wit: The N 2 of the NW. 1 and the N2 of the SW 1 of the NW. 1 Of section I5 of Twosnhip 22 Range I3 E of the Indian Meridian, and containing IOO acres, more or less for the full term of IO years from date hereof, and the said arrty of the second part, in consideration of said premises, as above set forth, covenants and agrees with the party of the first part to pay said party of the first part as rental for the same the sum of Twenty-five dollars, being at the rate of Twenty five cents per acre, payable as follows, to wit: Pageble in advance on the first day of each January during the continuance of

Jaid party of the second part further covenants and agrees that at the expiration of the time# mentioned in this lease he will surrender to said party of the first part pegcable possess on of the leased premises in good condition, the usual wear and unavoidable accidents excepted, and that failure r, neglect or refusal to pay the rental, or any part thereof, when the same becomes due and payable, as herein provided, shall work a forfeiture of this lease and entitle the party of the first part, or whomsoever shall be lawfully entitled to said premises, to enter and take possession of the same.

Said pafty of the second part further covenants and agrees that he will comply with all the quarantine laws or customs in force in the Cherokee Nation, Oklahoma as to excluding diseased or infected cattle or other animals from the premises, and that he will comply with such regulation as may be adopted by the Sercretary of the Interior in the matter and that he will comply with all the regulation at any time adopted by said Secretary to prevent other allotments of individual Indians or tribal land from damage or interference by his cattle or other animals, and will muot in any manner intrude on other Indian allotments or tribal lands.

It is understood and agreed by the parties hereto that the use of the leased premi ses by said party of the second part, or by any one holding under him as a subleasee or otherwise, for any purpose not covered by this lease, or the failure by the party of the second part to pay the rental when same becomes due, or in case the party of the second part fails, neglects or refuésed to make improvements herein specified within the time mentioned, such failure, neglect chrefusal shall work a forfeiture hereb.

It is further understood and agreed by the parties hereto that the party of the second part will not permit any nuisance to be maintained on the pimises, nor allow
