This indenture made and e ntered into in quadruplicate on this 29th day of July A D 1908 by and between Sanders Cochran of Stilwell, Okla party of the first part and C.L.Brown of Tulsa Okla , party of the second part, under and in accordance with the provisions of existing laws and the rules and regulations prescribed by the Secretary of the Interior relative to grazing leases in the Cheroke Nation, Oklahoma.

WITNESSETH: That said party of the first part for and in consideration of the covenants of the s id party of the second part, hereinafter set forth, does by these presents lease to said party of the second part, for grazing purposes only, the following de scribed tract of land lying and being within the limites of the Cherokee Nation and within the State of Oklahoma, to-wit : The NE₄ of the SE₄ and the NE₄ of the SE₄ of the SE₄ of section I9 of township 22 of range I3 E of the Indian Meridian and containing 50 acres , more or less for the full term of I0 years from date hereof, and the said party of the second part in consideration of said premises, as above set forth, covenants and agree s with the party of the farst. part to pa y said party of the first part as rental for the same the sum of Twelve and 50.100 Dollars being at the rate of twenty five cents per acre payable as follows :-

Payable in advance on the first day of January of each year during the continuance of this lease .

Said party of the second part further covenants and agrees that at the expiration of the time mentioned in this lease he will surrender to said party of the first part peaceable possession of the leased premises i n good condition, the usual wear and unavoidable accidents excepted, and that failure, bneglect or refusal to pay the rental, or any part thereof, when the same becomes due and payable, as herein provided, shall work a forfeiture of this lease and entitle the par y of the first part, or whomsoever shall? be lawfully entitled to said premises, to enter and take possession of the same.

Said party of the second part further covenants and agrees that he will comply with all the quarantine laws or customs in force in the Cherokee Nationa, Oklahoma as to excluding deseased or infected cattle or other animals from the premises, and that he will comply with such regulations as may be adopted by the Secretary of the Interior in the matter and that he will comply with allthe regulations at any time adopted by said Secretary of prevent other allotments of indivudual Indians or tribal lands from damage or intereference by his cattle or other animals, and will not in any manner intrude on other Indian all otments or tribal lands .

It is understood and agreed by the parties hereto that the use of the leased premises by said party of the second part, or by anyone holding under him, as a sublessee, or toherwise, for any purpose not covered by this lease, or the failure by the party of the second part to pay the rental when the same become due, or in case the party of the second part fails, neglects or refues to make the improvements specified within the time mentioned , such failure, neglect or refusal, shall work a forfeiture hereof.
