This agreement, made and entered into on this 20th day of June A.D. 1908 by and between Robert Nero party of the first part and H.L. Hollingsworth of Broken Arrow, Oklahoma, party of the second part.

WITNESSETH: That party of the firstpart, for and in consideration of the agree- ments, covenants and considerations of second party, as herein after set out and agreed to be done, performed and paid by him, does hereby let, lease and demise unto said second party, his heirs, executors , administrators and assigns, for the full term of five years from date hereof, for agricultural purposes, the following described premises and realstate, to-wit:

The south-west quarter of the Northeast Quarter of Section Twenty eight (28) Township Eighteen (18) North, Range Thirteen (13) East, in Tulsa County, Oklahoma containing 40 acres more or less according to the United States survey whereof .

And second party agrees in consideration of the agreements of first party herein, to pay first party as rental for said land and premises the sum of twenty dollars per year, all payable as follows , to-wit:
