The covenants herein contained shall extend to and be binding upon the heirs, executors, administrators, successors, or assigns of the parties to this lease, and this lease shall be subject to all rules and regulations prescribed by the secretary of the Interior , or which may be hereafter so prescribed by him .

The parties of the second part hereby acknowledge themselves to be firmly bound for the faithful performance of the stipulations of this indenture of lease by and under the bond made and executed by the parties of the second part as principal and  $\stackrel{o}{\sim}$  as suret is entered into the \_ day of , and which shall remain on file i n the Indian office .

It is expessly understood and agreed by the parties hereto that if the Secretary of the Interior is at any time satisfied that any of the covenants contained herein or that any of the provisions of any regulations heretofore or that may hereafter be lawfully prescribed by him, have been or are being violated , he may cancel this lease, and hat his deflaration of cancellation shall be effective without resorting to the Court or without further proceedings and that the lessor shall then be entitled to the immediate possessio n of the land .
