THIS INDENTURE, Made this 21 day of April 1908, by and between Emily

M Campbell of Tulsa Extex, Tulsa County, State of Oklahoma, executrix of the last will and
testament of Wilbur Emory Campbell, deceased, of the first part, and T.C? Hughes of
Tulsa County, State of Oklahoma, of the second part:

WITNESSETH: That whereas, under the terms of the said last will and testament of the saidmWilbur Emory Campbell, decedent, said will havving been admitted to probate in the County Court of the County of Tulsa, State of Oklahoma, on the IOth day of December 1907, power was given to the said executrix, Emily M Campbell, to dispose of, in such manner as seemed to her fitting, and all real estate decedent died seized of, and to sell and covey the same by good and sufficient warranty deeds; and,

WHEREAS, on the 22 day of January I908 said land heren described and conveyed was duly appraised according to the statute in such case made and provided, and the value of said land found upo n appraisment by the appraisers thereof to be the sum of \$ 700.00 as appears from duly filed and approved report of said appraisers on file in the County Court of Tulsa County, State of Oklahoma; and,

Hughes, for the sum of \$ 900.00 said sum being more than 90 % of the appraised value thereof, and no greater sum than above specified being obtainable; and,
