WITNESSETH: That the said lessors for and in consideration of the sum of One Dollar in hand well and truly paid by the lessee the receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of the lessee to be paid, kept and performed have granted, demised leased and let and by these presents do grant, demise, lease and let into the lessee his heirs or assigns all the oil and gas in and under the following <sup>described</sup> tract of land, also the said tract of land for the sole and only purpose of entering upon, operating thereon and removing therefrom said oil and gas for the term of ten years from date, and as much longer thereafter as oil or gas is produced thereon, with the right to use oil gas or water therefrom and all rights and privileges necessary or convenient for such operations, also the right to remove at any time all property, pipes and improvements placed or erected in or upon said land by the lessee.
