That said first party for and in consideration of the rents a WITNESSETH: and covenants herein after made, to be done paid and performed by the party of the second part, as guardian aforesaid, being duly authorized in the premises, this day and by these presents does demise, let and lease to the party of the second part for the term of Five Years from Istday of Jan 1908 the following described premises

The S 2 of the SE 4 of Section 28 Township 19 Noth Range 14 East, situated in Tulsa County, Oklahoma .

It is covenanted and agreed that the party of the second part will pay said party of the first part as guardian of said ward the sum of Forty Dollars annually during the term of this contract payable as follows: - Sort, Collarion the first day of Farmany during the life of this control.

The party of the second part in addition to the covenants on his part hereinfbefore set out to be done and performed agrees to build fences as follows : fence and cross fence to cut the said field off from pasture, with a good three wire fence and to build atwo-roomed house as hereinafter shown to be put upon said premises .
