SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 25 and NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 25 all in Town 21 Range 13 East containing 50 acres according to U.S. Govt survey thereof .

Together with all the appurtenances thereunto belonging . The consideration which said second party or person designated by said second party shall pay for said land is 750.00
