## ORDER OF COURT .

Be it rememberedthat hertofore on this day the applicants. herein filed application in this court asking the order of approval of a deed executed by applicants to James W Orr of Vinita Okla for = the inherited interest of the applicants in the following described lands situated in the County of Tuls a State of Oklaho amf to-wit :-

W2 of SW4 of Section Twenty Five (25) Also NE4 of NE4 and E2 of NW4 of NE4 and N2 if SE4 of NE4 and SW4 of SE4 of NE4 of Section thirty mix (36) Township twenty one (21) North Range twelve (12) East.

Said application setting forth that the applicants are full bloods Cherokee citizins and that the lands described were allotted lands, the first of said tract belogging to one Thompson Walker now deceased and the latter of said tract being the lands in section Thirty six(36) belonging to John Walker ,, now deceased . That the applicants are heirs of Thompson Walker and that the applicants, except as to Emma White are all heirs to John Walker, and as such heirs took and now own, hold and possess an undivided interest in said lands .

The applicants Katie White was the widow of John Walker and the Mother of Thompson Walker; That Thompfson Walker diedafter John Walker died and that Thompson was heir of John Walker.

That John Walker left as heirs Katie White, his surviving wife, Susie White, Rosa Walker, Jack Walker, John Walker, Nannie Walker and Thompson Walker That Thompson Walker died later and left a s his heirs Katie White, his mother, whose former name was Katie Walk Zér, Susie White, Emma White, Rosa Walker, Jack Walk er and Nannie Walker all brothers and sisters of full bloods except Emma White, who was a sister to a half blood.

Said pettiton futher alleges that all of the appicants reside in Craig County Okla and that said lands are practically of no benefit or value to said applicants that they are deriving bo rent theref from; That owing to the divided interests and the unsettled condition of the titles of said lands, we dee Mit wise to sell their interests therein.

Said pettitin further alleges thatJames W Orr of Vinit aOkla? has offered to purchase said lands on the basis of Ten Dollars (\$I0.00) per acre, and allow, therefor, to Katie Walker the value of one child's interest for her life estate in Thompson Walker's and her dower interest in John Walkers land and pay the sum of (\$642.00) Six Hundred Forty\_-Two Dollars.

The said Emma Wgite not having any interest in the lands of John Walker, except through Thompson Walker, said moneys would be divided as follows : The said Money agreed to be paid will be paid in the following proportions: To Katie Walker Two Hundred Sixty Four (\$264.00), to Emma White One Hundred Fourteen (\$114.00) to Susie White
