to his credit at First National Bank of Tahlequah Okla and a failure on the part of the second party to comply with the terms of this covenant by either commencing a well within the time aforesaid or paying said rental shallrender this lease and agreeme nt null and void and not to remain or be continued inforce or be revived without the coonsent of both parties in writing and all rights, claims and demands of any kind or nature of any and all parties hereunder shall thereupon cease, determine and be extinguished with like effect as if this agreements had never been made .

It is understood that all the terms and conditions between tha parties shall hereto extend and apply to their respective heirs, executors, administrators and assions .
