ORDER CONFIRMING OIL AND GAS MINING LEASE.

Now o n this 18th day of Aug 1908 comijgn on to be heard the petition of L.P. Mc Guire guardian of the person and estate of William Baysinger a minor and it appearing to the Court that he, as such guardian on the 18th day of August 1908 under the general order of Court relative to leasing minor lands for oil and gas mining purposes , amade execute d and delivered an oil and gas mining lease to William Everts said lease coveri g t the following described lands belonging to William Baysinger , to-wit :

Northeast quarter ( N E 1/4 ) of Section Twenty three (23) Township seventeen (17) North Range Thirteen (13) East containi g 160 acres more or less .

And it further apeating to the satisfaction of the Court that the lease as made is for the best interest\$ of said minor ward, and that it provides for an immediate developement of said lands for oil and gas mining purposes , and that it further appearing that the lesse provides for 1/8 royalty of all oil produced and saved from the said premises and that in case gas is found , lessor is to receive \$ 150 per year for each well so long as gas is sold ther efrom off the premises .

IT is therrefore ordered, adjudged and decreed by the Court that the lease be and the same is hereby ratified, confirmed , approved and declared valid .
