Now, on this 18th day of Aug 1908 coming on to be heard the petition of L.P. Mc Guire Guardian of the person and estate of Oscar H Mc Guire a minor and it appearing to the Court that he, as such guardian, on the 18th day of Aug 1908 under the general order of Court relative to leasing minor lands for oil and gas mining purposes, made, executed and delivered an oil and gas mining lease to William Everts, said lease covering the following described lands belonging to Oscar H McGuire, to-wit :
