## -----OIL AND GAS MINING LEASE :-----

This agreement Made this 17th day of August A.D 1908 by and betwe n Annie E Koch, party of the first part, and O.R. Hoawrd, John F Lawrence and D Vensel parties o of the second part, withn esseth :-

That the said party of the first part for One ( \$1.00) Dollra and other good and valuable cosideratio<sup>thereof</sup> the receipt ~~of which~~ is herby acknowledged, and in further consideration of the covenants and agreements hereinafter mentioned, has grenated, demised leased and let unto the parties of the second part, thair heirs and assigns , all the oil and gass in and under that certain tract of land hereinafter described, and also the said tract of land for the purpose and with the exclusive right of drilling and operating for said oil and gas, which said t ract of land is situated in Tulsa County, State of Oklahoma, and described as follows, toowit :-

North One-half of south-east quarter of South-west quarter; south-east quarter of South-east uqrter of South-west uqrter; South-east quarter of South-west quarter of South-west quarter; and south-west qquarter of south-east quarter of south-west quarter of Section Twenty (20) Township (Twenty One(21) North , Range Thirteen (13) East, containig fifty acres more or less .

The party of the first part grants the further privilege to the parties of the second part their heirs and assigns, of using sufficient water and gas from the said premise s <sup>for the operation thereon and all right and privilege necessary</sup> necessary or convenient for conducting said operations and the transportation of oil and gas and the right to remove at any time machinery ~~and building~~xxxx
