Whereas, the plat of said town was approved by the Secretary of the Interior on the 11th day of April 1902 and was duly placed on file; and/

Whereas, the said commission has appraised all of the town lots included in said plat at their true value excluding improvements, which appraisal has been approved by the Secretary of the Interior, and,

Whereas, the said Commission has awarded the real estate described heretofore to Theophile Meerchaert Bishop, Trustee of the Roman Catholic Diocese of Oklahoma who has paid One Hundred and Five & 15/100 ( 105.15) Dollars the full amount
