THIS AGREEMENT, Made this 2nd day of July A.D. 1908, between ~~Manuel Hirsh~~ Nannie E Chambers and Wiley E Chambers of Claremore Okla lessor and The Iron Mountain Oil Company /lessee.

WITNESSETH That the lessor in consideration of Twenty Dollars the receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained, do hereby demise and grant unto the Lessee its heirs, successors and assigns, all the oil and gas in and under the following described tract of land, and also said tract of land for the purpose and with the exclusive right of operating thereon for said oil and gas, together with the right of way, the exclusive right to lay pipe over and upon, to erect and maintain all machinery, buildings, powers, tanks, fixtures, etc, necessary or required in the operation for oil and gas and also the right to remove at any time all property placed thereon by the lessee, which tract of land is situated in the Township of County of Tulsa, State of Oklahoma.
